## New Divers Join Fallon Fire Department's Dive Team

During the first weekend in November, four new divers finished and passed the Open Water dive certification for the Fallon/Churchill Volunteer Fire Department Dive Team. The Dive Team performs rescues and recoveries throughout Churchill County and when called on for neighboring departments. They are a crucial part of the community.

While it is not required for firefighters to be dive-certified, many members are eager to join the dive team. To get certified, these firemen had to go through roughly four days of pool work, book time, and a two-day dive in Lake Tahoe.

For this training, the department had an instructor from the Sierra Dive Center in Reno. They went over various diving situations, potential hazards, and other things to look out for. They then moved on to pool work to practice surface and underwater skills and to learn how to use the equipment. Equipment used included wet suits and dry suits, as well as SCBA equipment for breathing underwater.

The Dive Team has all its gear loaded in a dive van that is kept ready to go at a moment's notice. The ditches and canals in Fallon are hazardous, and when vehicles crash into them or other incidents occur, it is up to the dive team to make recoveries. Swiftwater training is also provided for use in canals where the current is strong in certain areas.

Additionally, with Lahontan Reservoir nearby, it is vital to have the dive team ready in case of an emergency.

Members of the dive team continue training once a quarter to keep their skills up to date.

After the initial training, the department provides blackwater diving training, which is conducted in conditions with no visibility. This is useful in areas like Lahontan Reservoir as well as the miles of irrigation canals throughout the community where visibility is severely limited beneath the surface.

The newest members of the 15-man dive team are Dan Shaw, Rafe Brown, John Ezzel, and Dave Brown.

## Churchill Farmers Wait on \$800k State Ag Appropriation

Last summer, the Nevada Legislature and Governor Lombardo approved and signed into law an \$800,000 appropriation for the Nevada Department of Agriculture (NDA). This money was meant to replace federal funds for Home Feeds Nevada, which were rescinded last March. However, Churchill County farmers report that they have not heard from the NDA about when purchase orders for the program will resume.

Home Feeds Nevada, like similar farm-to-food-bank programs in other states, is usually funded through a block grant from the Local Food Purchase Assistance Cooperative Agreement Program (LFPA). In 2025, LFPA would have funded about \$4 million in purchase orders for Nevada's farmers and \$500M nationwide.

HFN purchases fruit, vegetables, eggs, dairy products, and meat from Nevada farmers. They do so by issuing declining purchase orders, in which they arrange for future delivery of unspecified amounts of food from a vendor based on that vendor's credible prediction of the quantities and timing of their various crop harvests. These vendors arrange transportation to Nevada's two major food bank hubs: Food Bank of Northern Nevada (FBNN), located just off USA Parkway in Sparks, and Three Square in Las Vegas. The purchase orders are then paid in chunks as each is fulfilled and confirmed by the food banks.

After receiving Home Feeds Nevada deliveries, FBNN and Three Square apportion and ship locally farmed food, along with donations and food bank-purchased food staples such as potatoes and beans, and USDA commodities to hundreds of partner pantries across Nevada.

Nevada state senators Fabian Doñate and Edgar Flores, both Democrats from Las Vegas, co-sponsored the bill. They, along with the Legislative Counsel Bureau, drafted Senate Bill 233, which would have used \$800,000 to create and fund the state Task Force on Farm Labor. However, on or about March 10th, 2025, after the start of Nevada's legislative session, the USDA rescinded funding for this program and a similar farm-to-school program, Local Food for Schools. As such, the senators worked quickly, with help from Fallon-based Small Business Development Corporation business coach Kelli Kelly, to author an amendment to SB 233. The amendment deleted the language that created the task force and shifted the \$800k to Home Feeds Nevada.

Senator Doñate traveled to Churchill County during the legislative session to meet with the owner/operators of Alanis Family Farms, a Home

## Captain's Log


## One Big Round

Feeds Nevada vendor, in advance of the bill's passage. Cuco Alanis, whose family grows produce at Lattin Farms through an agreement with the Lattin family, said, "My dad did a lot of work to get that [bill] done", referring to the many conversations his father, Adrian Alanis, had with officials and media. A Reno Univision news crew and other reporters visited Churchill Farms as word spread about the distress caused to Nevada farmers by sudden federal budget cuts, highlighting the emergency need for alternative sales channels for farmers, such as the remedy proposed by SB 233.

Last June 10th, Governor Lombardo signed Senate Bill 233 into law. According to language in the bill, the statute created by the bill became "effective on July 1st, 2025," and that \$800,000 was to be deposited from the State General Fund into the Nutritious Food Purchase Account. However, local farmers, Cuco and Adrian Alanis, and Ron Peterson, owner of Pickin' and Grinnin' farm stand, all experienced vendors to the HFN program, report that not only have they not received any money or purchase orders from the state, but that they've had no communication with their usual NV Dept. of Agriculture contacts. Peterson acknowledged that their previous purchasing agent is now working in a different role.

The Fallon Post received a statement from Patricia Hoppe, Nevada Department of Agriculture Division of Food and Nutrition Administrator, in response to questions about when the NDA would resume Home Feeds Nevada operations and orders:

".... the NDA has not been able to utilize these funds to purchase food for the Home Feeds Nevada program as funds were not issued to the Department until Sept. 30, 2025...

[Previous] declining purchase orders expired

on June 30, 2025. This new spending plan

included the development of new declining

purchase orders.... A new spending plan has not been finalized, and funds have not been spent...

It is still the intention of the NDA to purchase food through the Home Feeds Nevada program, but this will depend upon the available storage and needs of food bank partners."

Ms. Hoppe stated that uncertainty about storage capacity relates to evolving plans to mitigate Nevada's expected food insecurity needs. Due to the stoppage of funds for SNAP benefits or federal worker salaries during the government shutdown, food banks will double food deliveries as early as next week. The SNAP cutoff was announced on October 23rd.

The Alanises and Peterson understand the Ag Department's situation and the fact that Home Feeds Nevada didn't receive funds until six weeks ago. They agree with Ms. Hoppe's statement in that these large purchase orders must be agreed upon well in advance of planting. And for that reason, they are especially concerned about the lack of communication, which Cuco Alanis described as unusual in his experience. Peterson said, "It's important that we have a full understanding that we, the farmers—along with our Home Feeds Nevada partners—are aware that we need at least ninety days...to establish a planting schedule."

He continued, "once we are aware monies are available to farms.... we need to know [specifics] now because we have to look at seed prices, condition of the soil to prepare and.... the dollar amount which would be available to a given farm."

The Alanis and Lattin families still have an abundance of great fall produce at the Lattin Farms store at 1955 McLean Rd. in Fallon. People can load up on spaghetti squash, butternut squash, garlic, cherry tomatoes, tomatillos, and of course, the Lattin's world-famous raspberry jam.

## **Surviving the Uniform:** Dr. Gilmartin on Life Beyond the Badge

Local and Regional Law Enforcement Officers and First Responders Receive Training on Emotional Survival and How to Beat Burnout

*Imagine always being in a state of* hypervigilance, rarely able to relax fully. Now imagine extremely long work hours, double shifts, overtime, mandated or voluntary, and even second and third jobs. Add one of the most crucial and dangerous jobs in the country to the mix. Yes, you guessed it. You are a law enforcement officer or a first responder.

Many Americans don't have to imagine this; they are law enforcement officers, EMTs, firefighters, or others serving in high-risk, highintensity jobs. However, unlike in countries like Australia, where first-year cops get an average of nine weeks of paid leave, U.S. law enforcement officers usually get two weeks of vacation. That is, if their department is not so understaffed that they cannot take their accrued time off.


In a Nov. 4 presentation at the Fallon Convention Center to regional law enforcement officers and first responders, Dr. Kevin Gilmartin, a 20-year law enforcement veteran and behavioral scientist specializing in public safety, discussed two devastating shooting incidents in which officers inadvertently drew their firearms instead of their intended Tasers. While examples like these are extremely rare, they have forced departments to examine things like officer safety in relation to multiple shifts, physical and emotional fatigue, and the overall health and well-being of their officers.

Dr. Gilmartin's intention was not to draw attention to worst-case scenarios, but to address compromised officer safety. In his book "Emotional Survival for Law Enforcement: A Guide for Officers and Their Families," Gilmartin addresses critical issues facing modern American cops. A large portion of the training focused on "hypervigilance," the heightened alert state required on duty in policing, which, over time, carries off-duty consequences. This state, says Gilmartin, can lead to poor sleep, lack of interest in former hobbies or recreation, and a "when I retire" mentality.

Gilmartin also discussed the "Biological Rollercoaster" for law enforcement professionals, which explains the "on duty" high sympathetic nervous system arousal followed by a drop into "off duty" parasympathetic low arousal, which can lead to emotional fatigue, detachment, or cynicism. He urges officers to build or maintain interests outside of their jobs, which could mean the difference between enjoying life, entering a rewarding retirement, and staving off preventable

life-threatening illnesses that cut too many good cops' lives short. Dr. Gilmartin tells officers not to wait. Do the good stuff now!

The training was organized by POOL/PACT, the state's risk-management group that provides human resources, law enforcement safety, health, wellness, and more to state and local agencies. Chief Financial Officer for POOL/PACT, Alan Kalt, said Dr. Gilmartin's "Emotional Survival" training is a standard for law enforcement training nationwide. It is part of the Fit for Retirement program offered to public safety and first responders.

The training was requested by Churchill County Sheriff Richard Hickox and attended by over 30 law enforcement officers and first responders from the Fallon Police Department and sheriff's departments in Storey, Mineral, Lyon, Elko, and Eureka counties. "We were pleased to coordinate this as part of our four-month health and wellness metabolic reset program for law enforcement," said Kalt, who notes several spouses in attendance. "Emotional and mental health are very important and often overlooked elements to the overall physical well-being of law enforcement officers." Courtesy of POOL/PACT, every participant received Dr. Gilmartin's book to read and share with their family. Loved ones may also benefit from a better understanding of the mental and emotional stressors associated with law enforcement work.

Sheriff Hickox, a fierce advocate for the principles taught in "Emotional Survival," said Gilmartin's information is vital to peace officers and their families at any stage of their careers. "I was first introduced to his training shortly after I got hired in 1999," said Sheriff Hickox. "I purchased his book and read it. I am sorry to admit that I did not absorb as much of the wisdom contained in it as I should have, but I had the opportunity to re-read it several years later and

absorbed more, viewing the information from a slightly different lens. This allowed me to absorb more of the knowledge."

Hickox went on to state that for his deputies and all law enforcement officers, "I believe it one of the most important books a peace officer could read and share with his family. It contains insights, scientific explanations as well as words of experience that will help you and your significant other understand some of the changes you are going through and implement skills and strategies to cope and deal with them."

Many law enforcement officers became familiar with Dr. Gilmartin and "Emotional Survival" at the beginning of their careers and have long worked to apply his practical wisdom. However, like the sheriff, many officers find the information relevant in different ways the longer they work in law enforcement. "Dr. Gilmartin has been a reference for emotional survival for law enforcement throughout my entire 15-year career," said Lt. Mike Hardin with Churchill County Sheriff's Office. "He has been referenced by almost every mentor I have had. It was amazing to see his practices in person, and it provided a lot more gravity to his ideals."

#### ANTHONY EMANUEL KLENAKIS

July 1, 1940 - October 24, 2025

Anthony Emanuel Klenakis, 85, passed peacefully on Friday, October 24, 2025, after a brief illness.

Tony or Coach Klenakis was born on July 1, 1940, to Christos and Lucille Galanis Klenakis in Springfield, MA. He was the middle of three children and grew up amidst a large Greek family in Agawam, MA.

Tony's passion for sports was evident from a young age; his strength, agility, and dedication made him a

standout on the gridiron. Playing all four years in high school, he won All-Star Western Massachusetts and championships. He was also a standout athlete in baseball and hockey.

Upon graduating from high school in 1959, he headed west to Trinidad Junior College in Colorado, where he played football for two years. Wanting more, he headed west once again to attend the University of Nevada, Reno. While there, he played football and baseball and pursued the love of his life, Norma Sheley. He graduated from UNR in 1961 with a BA in education and married Norma.

Coach Klenakis began his teaching career at Wooster High School in Reno, where he coached football and basketball. During summer breaks, Tony pursued his Master's degree in school administration, which he obtained in 1964.

Tony and Norma's first son, Chris, was born in 1964, and in 1966, the young family moved to Fallon, where Tony taught history, PE, and health at Churchill County High School. He was the head football coach for the varsity team, an assistant baseball coach, and the driving force that began the wrestling program at CCHS.

In 1967, Tony and Norma's second son, Tony, was born. Coach Klenakis was not just a coach, but also a mentor and father figure to many young men. He taught them to practice hard and play easy. He taught them about integrity and

honor in all things. While he was tough, he never expected anything from his players that he himself was not willing to do. He led his teams to three straight state championships in 1976, '77, and '78.

In the summers, the family would pack up the truck and horse trailer and head to Boise, Idaho, where they raced horses at Les Bois.

Coach Klenakis left CCHS in 1980 and headed to California, where he trained thoroughbreds and traveled the racing circuit. In the early

2000s, he moved Klenakis Racing Stables to Arizona, where he trained the thoroughbreds until his retirement in 2019.

Upon moving back to Fallon, he didn't sit idle but went to work as a cashier at Walmart and enjoyed seeing friends, former players, and being part of a team.

Tony's life was so rich, diverse, and full of adventure. He loved sports, whether he was playing, watching, or coaching—he always strived to be better and help others better.

No matter how long he was away from Massachusetts, his love for the Boston Red Sox, Celtics, and Bruins never wavered. He was an avid reader. loved Jeopardy, loved opera, ballet, and musicals. He cherished his time with friends and family.

Tony is preceded in death by his parents, his sister Marie, brother-in-law Gary, son Tony, and infant grandson Antaeus.

Tony is survived by his wife of 62 years, Norma; son Chris (Louise); daughter-in-law Kim; grandchildren Nikos, Lucy, Matthew, Mark, and Elizabeth; brother John (Ann); brother-in-law Charles (Katherine); and numerous cousins, nieces, and nephews.

A memorial service will be held at Parkside Bible Fellowship on Saturday, November 15, 2025, at 1:00 p.m. A private burial will be held at a later date.

## Winterizing Your Vehicle For Winter

Old Man Winter is taking his time finding Fallon this year, but he will see us all too soon. If you are new to the area, you may not be familiar with how harsh the Nevada winters can be. Here are some reminders from Tedford Tire and Auto Service and O'Reilly Auto Parts.

Cars, trucks, SUVs, RVs, marine vehicles, and even golf carts all have batteries that can fail over time, especially in extreme temperatures. Before cold weather sets in, stop by any auto parts store, Tedford's Tire and Auto Service, or Les Schwab, and they will test your battery for free to make sure it's strong enough to survive the winter.

It's important to gear up for winter and be prepared with winter accessories before a storm hits. Be sure to carry extra water, medications, blankets, and snacks in case you are unable to get to your destination due to Old Man Winter.

Have a window scraper in your vehicle and always clean the inside of the windows; it will allow your vehicle's defroster to work more efficiently. Check the antifreeze, oil, and windshield washer fluid levels often. Antifreeze mixture should ideally be 50% water and 50% antifreeze, and can be checked with a simple tester. Consider using a windshield washer fluid with a deicer, or add isopropyl alcohol to the regular washer fluid to help with light frost and ice on your windshield in the mornings. Randy Sharp of Tedford Tire and Auto Service said, "DO NOT pour hot liquids on your windshield in the frosty mornings, as it can cause the window to crack."



If your wiper blades have been streaking, skipping, or smearing, they should be replaced. Consider installing a winter blade that's designed for snow and ice.

Check your vehicle's heater and defroster. Run your heater and defroster to make sure they're warm and working adequately. If they are not, you will need to contact a mechanic to figure out what the issue may be.

Keeping your fuel tank at the top half of full during winter will not only ensure you don't run out of gas in the cold but also help you avoid idling in a storm or traffic. It will also help prevent damage to your fuel system.


Test all your lights —headlights, taillights, brake lights, turn signals, and hazards. You will be driving in the dark more often as the days get shorter. It's not a bad idea to keep a spare set of

bulbs on hand to change if needed during the long winter.

Randy Sharp, of Tedford Tire and Auto Service, cautions that as the season gets colder, tire pressures drop. Ninety percent of all tires are under-inflated in the winter months. Tire tread and pressure are always important, but especially when you're driving through the winter months. Nevada allows motorists to run their vehicles on studded snow tires from October 1 through April 30 of each year.

Suppose your brakes aren't working as smoothly, quietly, or effectively as they used to. In that case, it's a good idea to visually inspect them or take them to a professional technician for diagnosis.

These are some winter driving safety tips that can also be used all year. Don't let Old Man Winter catch you off guard for your winter driving.

# Fallon Launches "America 250" Planning with Yearlong Celebration in Mind

Community leaders and volunteers gathered at City Hall for the first meeting of the Mayor's America 250 Commission, launching an effort to plan how Fallon will mark the nation's 250th birthday.

Mayor Ken Tedford said the goal is to tie as many local events as possible into a unified "America 250" celebration, from the community Christmas tree lighting through the Fourth of July, with common flags, banners, and a logo signaling the anniversary.

The commission will be co-chaired by volunteer Michon Mackedon, who served on Tedford's Millennial Commission in 1999, and Mike Berney, who will help coordinate events that connect with Maine Street and the Fallon Theatre.

"When Bob Erickson (City Chief of Staff) and I sat down with the list, we could tell you exactly why each of you is here," Tedford told the group. "You all touch different parts of the community — schools, arts, business, events. We're going to need every bit of that reach."

Early work will focus on building a master calendar for 2025–26, identifying existing events that can be branded as America 250 activities and spotting gaps where new events might make sense, with city staff managing and coordinating the calendar.

The first visible step will be this year's com-

munity Christmas tree lighting. City staff member Erik Fain has contacted the fireworks vendor about adding a special America 250 element to the tree-lighting show, and a custom "250" topper is being designed for the downtown tree.

Members also discussed encouraging businesses to decorate in red, white, and blue for both the holidays and the coming year, including window painting and historic-style flags along the Maine and Williams corridors.

An America 250-themed chalk art festival is planned for May 29–30 on and around Carson Street, with professional chalk artists and students working side by side in designated areas for artists, local adults, and kids. The festival will feature live music and food trucks and carry a red, white, and blue America 250 theme, while still allowing artists creative freedom.

The commission discussed reviving the PTA Day kids' parade, which once brought elementary students downtown in costumes, and pairing it with old-fashioned children's games that echo 18th-century activities —simple contests, races, and hands-on demonstrations — that could fit into a park celebration.

For the Fourth of July, plans center on a full-day event at the park featuring live music, food vendors, and kid-friendly contests. Some suggested incorporating historical reenactors and a "Paul Revere race" for younger children using hobby horses. The longstanding fireworks show would remain the evening anchor, with hopes of additional patriotic touches as budgets and logistics allow

Rather than building everything from scratch,

the commission plans to layer America 250 themes onto existing events. The Churchill Arts Council is planning a 1940s-style USO show in May with patriotic music, and the Churchill County Junior Livestock Show and ag mechanics contest could encourage projects and decorations tied to 1776, American innovation, and rural traditions

Beyond the year of events, city officials are exploring a permanent legacy project tied to America 250. One concept involves a sculpture or art garden at the Oats Park Art Center, potentially featuring a work by artist John Mason and a redesigned public space where visitors can walk, sit, and reflect. Another idea is to recreate the historic courthouse fountain, the Draper Self Culture Club's horse-watering fountain that once stood downtown at what is now the 3C Arena, and dedicate it in connection with the anniversary, working with the museum to get details right and, if possible, incorporate language from the original sign.

"These are the kinds of things people remember and take pictures in front of for years," Tedford said. "If we're going to mark 250 years, it would be good to leave something lasting."

The commission plans to meet again in January with a draft master calendar and more details for each event. In the meantime, members will spread the word through their organizations and gather input. Community groups, service clubs, churches, and businesses interested in tying their events into the America 250 celebration will be invited to join the calendar and use the shared branding.

## Council Introduces Updates to Building and Fire Codes

The Fallon City Council on Monday introduced two ordinances that would update the city's building and fire standards, setting public hearings for Dec. 2 to gather community input before adoption.

Bill 807 would amend Title 17 to adopt the 2024 editions of the International Building Code and the Uniform Building Codes. The measure, introduced by Councilwoman Kelly Frost, was presented for introduction only. "This is for introduction only," Mayor Ken Tedford said, noting no further action would be taken until the December hearing.

Bill 808 would amend Title 16 to adopt the 2018 International Fire Code, including appendices B, C, D, and F, as modified by NAC 477.281. Councilwoman Karla Kent introduced the ordinance, and the mayor scheduled a Dec. 2 public hearing, where residents will have an opportunity to comment before any vote is taken.

Earlier in the meeting, the council approved minutes from the March 28, 2025, session and authorized warrants covering accounts payable, payroll, and customer deposits. Both items passed unanimously.

During the public comment period, resident Mr. Bridges praised the new fitness court at Laura Mills Park, calling it "marvelous, something special that ties it to our community."



Mayor Tedford responded with a laugh: "You probably got up more on that fitness court than I ever was, let's go for a walk." Turning to Councilwoman Frost, he added, "Thanks for having the idea of the fitness court, I hope everyone uses it."

The meeting adjourned following brief staff remarks.

Richard Anthony Davis pleaded guilty to Burglary of a Business, a Category C Felony, which is punishable by 1-5 years in prison and a fine up to \$5,000. Judge Stockard ordered a Pre-Sentence Investigation (PSI) and set sentencing for Jan. 13, 2026.

Joseph Robert Keller appeared for sentencing on Possession of a Controlled Substance (methamphetamine), a Category E Felony, to which he pleaded guilty on Oct. 14.

Judge Stockard stated he had not received the substance abuse evaluation, nor had an application for diversion been filed. He continued the case to Dec. 2.

Roman Alexander Clark appeared for sentencing on the Category C Felony of Non-Support of a Spouse, Former Spouse, or a Child, to which he pleaded no contest on Oct. 29, 2024.

Deputy District Attorney (DDA) Priscilla Baker told the court the state had received 12 months of payments. Therefore, amended information was filed, reducing the charge to a Gross Misdemeanor. Baker said the state wanted to encourage the defendant to continue making his payments on time and asked for a suspended 364-day sentence.

Churchill County Public Defender (CCPD) Jacob Sommer asked for a suspended fine.

Judge Stockard imposed fees and assessments, delivered a suspended sentence of 364 days in the Churchill County Jail, and placed Clark on probation.

custody at Northern Nevada Correctional Center. pleaded guilty pursuant to Alford to Attempt to Commit Sexual Assault on a Child Under the Age of 14, a Category B Felony, which carries a mandatory prison sentence of 2-20 years. An Alford plea allows a defendant to maintain their innocence while acknowledging that the prosecution has sufficient

evidence to likely secure a conviction and accept the legal ramifications of a guilty plea. If convicted. DeWitt will have to register as a sex offender and will be subject to lifetime supervision by the Division of Parole and Probation.

Judge Stockard ordered a PSI and set sentencing for Jan. 13, 2026, at 1:30 p.m.

Oscar Jamie Vargas, in custody, pleaded guilty to Possession of a Controlled Substance, First or Second Offense, a Category E Felony punishable by 1-4 years in prison and a fine up to \$5,000.

CCPD Jacob Sommer asked that Vargas be placed on probation. Court Services Director Brenda Ingram said the defendant was returned to custody twice in September.

Vargas told the court he was sorry and "should not have been doing what I was doing."

Judge Stockard granted probation on a suspended 12-24 sentence and ordered Vargas to obtain and follow the recommendation of a substance abuse evaluation.

Charles Marvin Lee, in custody, pleaded guilty to Count I, Possession of a Firearm by a Person Convicted of Domestic Violence, a Category B Felony, which is punishable by 1-6 years in prison and a fine up to \$5,000; and to Count II. Unlawful Acts Related to Human Excrement or Bodily Fluid Without Disease (for spitting on a Churchill County sergeant while in custody), a Gross Misdemeanor punishable by 364 days in jail and a fine up to \$2,000. Judge Stockard ordered a PSI and set sentencing for Jan. 13, 2026.

Michael Dwayne Alliston, in custody, pleaded guilty to Burglary of a Business, a Category C Felony punishable by 1-5 years in prison and a fine up to \$10,000.

Churchill County Alternate Public Defender (APD) Wright Noel addressed Alliston's custodial status and requested that his client be released on his own recognizance (OR).

Senior Deputy District Attorney (SDDA) Chelsea Sanford did not object, provided that Alliston has daily check-ins with Court Services and be drug tested before court appearances.

Judge Stockard granted the release under those conditions, ordered a PSI, and set sentencing for Jan. 13, 2026.

Autumn Castleberry pleaded no contest to Embezzlement of a Value of \$5,000-\$24,999, a Category C Felony punishable by 1-5 years in prison and a fine up to \$10,000. Judge Stockard

ordered a PSI and set sentencing for Jan. 27, 2026. Mekyel Kenneth Tybo sentencing continued to

## **Wolfson Granted Probation After Long Criminal History**

Steven Kord Wolfson appeared for sentencing in the Tenth Judicial District Court in Fallon on Nov. 4. Wolfson pleaded guilty on Oct. 7 to Category B Felony of Possession of a Controlled Substance, which is punishable by 2-15 years in prison and a fine up to \$50,000.

Deputy District Attorney (DDA) Priscilla Baker told the court that on Aug. 30, 2024, Wolfson was stopped for speeding and was arrested for an active warrant. The deputy obtained a search warrant for the defendant's vehicle, where officers found a glass

pipe with residue, a small scale, 30 milligrams of oxycodone hydrochloride, numerous small black baggies, and 54 grams of methamphetamine, Baker said the state believed Wolfson intended to sell the methamphetamine and that he had a history of selling drugs.

According to Baker, Lyon County conducted three controlled buys from Wolfson, resulting in purchases of 9.5 grams, 29.24 grams, and 16.5 grams of methamphetamine. She cited his Lyon County Pre-Sentencing Investigation (PSA), in which the defendant claimed he was unemployed, did not support himself by selling drugs, and was "just helping a friend" in what he alleged was a setup.

Baker noted Wolfson has not worked since 2023, said he "won some money gambling," and claimed he had no debt. Although he is now employed, Baker said he was not working at the time of the incidents in either Lyon or Churchill County. "It's common sense he was supporting himself with sales of methamphetamine," Baker argued.

She read Wolfson's criminal history, which began in 1990 and included numerous offenses, including possession for sale and transporting, possession in 2003 and 2006, possession for sale in 2010, possession in 2014. selling and attempted trafficking in 2016, trafficking and possession of a stun gun in 2020, and new cases in 2024 in both Lyon and Churchill counties. Baker said Wolfson's record also showed six probation violations and two parole violations.

"This defendant sells narcotics," Baker said, asking for a sentence of 48–180 months in prison and closing with, "Not in our county."

Churchill County Public Defender (CCPD) Jacob Sommer began his argument, "The defense agrees that this court should give a stiff penalty to Mr. Wolfson and run it consecutive to the Lyon County case. But certainly,

it is no surprise for anyone that the defense is asking the court to place Mr. Wolfson on probation."

Sommer said his client has been placed on probation by Lyon County and has been doing well, that he has been under Court Services supervision, tested regularly, and remained compliant for 130 days. He said Wolfson is employed and "has been working hard to change who he has been."

Sommer told the court Wolfson recognizes his past behavior was "unacceptable and even shameful," but that his conduct since arriving in Churchill County shows he is willing and able "to make it right—and the whole point of this justice system is to make sure that people never do this

Sommer said probation would give Wolfson a chance to continue what he has begun. He read from a letter submitted by New Frontier Treatment Center, which stated that Wolfson has been in counseling since July 17, 2024, has undergone a comprehensive evaluation, and is receiving targeted case management, psychosocial rehabilitation, and peer support.

The letter stated, "We have found Steve to be a very willing participant, seeking appropriate goals, and making a solid foundation for his recovery. He is actively engaged in changing his old patterns of behavior and attitude."

Sommer added, "To his credit, he has begun the process of showing this court the kind of man that he is going to be now, which is not the kind of man he was before."

Wolfson told the court, "First off, I just want to say that I have made more than my share of mistakes in the past. But I am no longer that

He said his eyes have been opened to the kind of person he was and that he is now attending NA and AA, being responsible, and living at the Lighthouse. "I realized where I was at, and I could see where I'm going. And I can assure you that I will not be anything of a menace to this society if given the opportunity," he said, adding that all of his associates are now sober and he enjoys going to work every day.

Wolfson said he has no desire for drugs and views the community in "a whole different way now." He ended his statement by saying, "I appreciate you listening. I hope you will allow me the opportunity of continuing on the road I am on currently."

Judge Stockard granted probation on a suspended 72–180-month sentence and ordered Wolfson to obtain and follow the recommendations of his substance abuse evaluation. He imposed a \$50,000 fine, suspending all but \$1,000, payable within 12 months. A Search and Seizure Clause for contraband was authorized.

"Mr. Wolfson, that's a large quantity of controlled substances and a very, very lengthy criminal history," Stockard said. "The state was not wrong in asking what they asked for. You have shown some signs, for the first time, that maybe you can lean in a different direction. Change is proof over time, not over four months, so we'll see."


"Oasis girls' golf has come a long way," Holleran said. "The girls set a high bar, and the good news is the boys are just as competitive. We're going to be right back in it next year."

## **CCHS Varsity Football Hosts Tense Playoff Showdown with Fernley**

It was standing room only in the packed bleachers during Friday night's region semifinal game between two staunch rivals. Fans in green, white, orange, and black braved the chilly weather with coffee and hot dogs as smoke from the grill drifted between the goalposts and stadium lights. The CCHS team took to the field under a bright moonrise – well-rested after earning a second seed bye and a week off - for their first game of the postseason. Squaring off against them was Fernley, who brought palpable enthusiasm and an appetite for victory after their win over the Lowry Buckaroos last weekend.

Despite their 42 -15 loss to CCHS earlier this season, Fernley immediately proved that this game would be different and claimed the first touchdown of the night less than two minutes in with Keeshawn Love rushing 82 yards into the endzone. A second touchdown four minutes later would give the Vaqueros a 14-point lead, as the energy and excitement from the visitors' stands began to dominate the field. The Greenwave refused to be shut out in the first quarter, however, pushing back when Calin Anderson completed a 20-yard pass from Camden Richardson, and managed to put points on the board for CCHS with four minutes to go. The Vaqueros blocked the extra point, which sent the rival teams into the second quarter 14-6.

Early in the next quarter, CCHS tied the score with a touchdown

and a daring two-point conversion. The battle raged as both teams fought hard to gain the upper hand in a neck-and-neck game. The score remained unchanged until the last minute of the second, when Fernley took the lead. The Greenwave pushed the ball into the endzone halfway through the third quarter – tying up the game again – and then pulled ahead just before the fourth after Calin Anderson completed a game-changing 79-yard pass from Matthew Bird.

## What's Cooking in Kelli's Kitchen - The Perfect Turkey

Friends, we have reached the Thanksgiving Holiday—one of the greatest days of the entire year. As Americans, we have a solemn obligation to cook a turkey with all of the fixings surrounded by family and friends.

Unfortunately, many Thanksgiving turkeys are disasters, turning out dry and flavorless. We are then forced to compensate by slathering gravy and cranberry sauce all over the meat.

For this week's recipe, I bring you a solution to both of these problems! I want to be clear that this recipe is not for the faint of heart, nor is it for anyone who enjoys under-seasoned meat or gravitates towards air fryers for cooking.

We are going to use 400 cloves of garlic here. And we are going to change the way you think about Thanksgiving Dinner forever. By brining and smoking a smaller-sized turkey, you'll end up with juicy and tender meat that everyone will love.

Through the gentle, slow cooking of an obscene amount of garlic, we'll end up with the most flavorful pan gravy you will ever eat.

If you don't have a smoker, you can cook this recipe in the oven. However, I strongly recommend smoking this turkey with mild pellets like pecan, hickory, maple, or a poultry blend.

I hope you enjoy this recipe as much as I do.

#### *Ingredients*

1 12-13 lb. turkey 16 oz. Package turkey brine mix 1 gallon Water

Ice as needed
3 sticks Unsalted butter, softened
1 bunch Parsley, finely chopped
1 tbsp. Garlic, finely minced

1 tbsp. Garlic, finely minced
1 tbsp. Extra-virgin olive oil
1 Lemon, zest and juice
2 lbs. Garlic cloves, peeled
Poultry barbecue rub, as needed
Cooking oil spray

12 oz. Light beer
2 cups Chicken stock
2 cups Dry white wine
½ cup All-purpose flour
1 tbsp. Worcestershire sauce



1/2 cup Heavy cream Kosher salt, to taste Black pepper, to taste

#### **DIRECTIONS:**

- 1. Bring a pot of water to a boil over high heat. Add lentils and cook, uncov
- 1. The night before, brine the turkey. Combine the turkey brine mix with 8 cups of water and heat over medium-high heat. Stir to dissolve any sugar and salt completely as the water comes to a boil. Once boiling and fully dissolved, remove from the heat and let chill. Combine chilled brine with remaining water and ice. Place the turkey in a large food-safe container and cover with the brine. Leave for about 12 hours.
- 2. The next day, remove the turkey from the brine, rinse off all of the salt and seasonings, and pat dry thoroughly.
- 3. Make the compound butter. In a bowl, combine the softened butter with one tablespoon of garlic, parsley, lemon zest and juice, and olive oil, and work until combined.
- 4. Place the turkey breast side up in a roasting pan. Carefully rub about half of the compound butter under the skin on top of each breast.

Spray the entire turkey with cooking oil, then spread the remaining compound butter over it. Cover the turkey liberally with barbecue rub.

- 5. Preheat a smoker to 350°F and place the roasting pan with the turkey inside. Cook the turkey, basting the skin with melted fat at the bottom of the pan periodically until the thickest part of the breast registers 160°F. It will carry over to 165°F as it rests. This may take anywhere from 3 to 4 hours.
- 6. About 90 minutes before the turkey is done cooking, add the 2 lbs. of garlic cloves to the bottom of the pan, pour in about half of the beer, and stir to combine.
- 7. Once the turkey is done, remove it from the smoker. The garlic on the bottom of the pan should be golden and should fall apart when pressed with a spoon. If the garlic is not soft enough, remove the turkey and put the garlic back in the smoker for 20 minutes or so, until it is ready.
- 8. Let the turkey rest for at least 30 minutes.
- 9. Make the garlic gravy. Strain the fat and cooking juices into a small saucepan. Place the garlic cloves in a large sauté pan or Dutch oven.
- 10. To the garlic cloves, add the chicken stock and white wine, and heat over until simmering. Reduce some of the liquid and cook the alcohol out of the wine.
- 11. With the reserved juices, heat over mediumlow heat and whisk in the flour to make a roux. Cook for a few minutes, whisking consistently.
- 12. Once the garlic gravy has reduced a little, gradually whisk in the roux until the desired consistency is reached, season with Worcestershire sauce, salt, pepper, and 1/2 cup of heavy cream. Using an emulsion blender, blend the gravy until smooth.
- 13. Carve the turkey and serve it with the 400 garlic clove gravy.


### Allison's Book Report:

"Punk Rock Dad: No Rules, Just Real Life"

Back before my husband and I became parents almost 16 years ago, we thought we had life figured out. We had our passions, our music, and a general distrust of 'The Man.' When our oldest daughter was born, followed shortly by a little sister, we found our anti-establishment spirits being tested. These days, I am trying to keep my sanity while teaching my teenage rebels to question authority and also to



pick up their socks. This week's book is a reread of one I first read when my kids were small, full of humor and heart that every reformed punk parent will appreciate.

Jim Lindberg's Punk Rock Dad: No Rules, Just Real Life is a hilarious and surprisingly tender peek into the chaotic double life of the Pennywise frontman. It is essentially a memoir that tackles the ultimate punk rock conflict: How do you rage against the machine when you are driving the minivan to soccer practice?

Lindberg, a veteran of the So-Cal punk scene, writes about the bizarre dichotomy of screaming "F\*\*k Authority" on stage one night and then supervising playdates and attending PTA meetings the next. He perfectly captures the struggle to stay true to your rebellious roots while morphing into a responsible dad to three daughters.

The book is filled with funny anecdotes contrasting his life on the road—the sweaty mosh pits, the late-night gigs—with the mundane realities of fatherhood, like packing lunches, dealing with sick kids, and trying to teach good values. He is the dad who insists on The Clash or The Descendents during the school run, reserving the right to believe the PTA head might be part of a vast conspiracy, all while paying his taxes and serving jury duty.

Despite the irony, Lindberg uses the DIY ethic of punk rock to tackle the challenges of parenting. He is trying to raise independent kids in a world that pushes conformity, proving that you can trade the mohawk for a carpool lane without losing your soul. It is an honest, fast-paced read that shows growing up does not mean giving up your passion; it just means your life now involves a lot more dishwashing and less slamming. It is a riot for anyone who has ever felt like a suburban sell-out but still secretly blasts Black Flag in the garage.

I cannot help but wonder what Jim might say all these years later about raising teens and young adults? Maybe a second installment is needed. One thing I know for sure it is that "parents of a certain age" will get a laugh out of this one! ## Postcards: A Woman's View

Last week, I wrote about Asa Kenyon, thought to be the Lahontan Valley's first non-Native American settler. He arrived here from California in 1854, a mere 8 years after the failed Donner Party mission (1846).

The fate of the Donner Party provides just one example of the many challenges faced by those early pioneers who settled in this Valley. Yet, settle they did, and most of them found at least a small measure of prosperity.

We can learn their names and the names of their wives and children from census data, and we can discover how much property they ranched or farmed from other records, but we have to fill in, by imagination, most of the details about their daily lives unless correspondence, diaries, or newspaper accounts form part of the record. In the case of early Churchill County settlers, John Brown and his wife, Delia Thompson Brown, we have both an early historical written description of their holdings and a diary left behind by Delia, which records some of the domestic details of her life here.

Thompson and West, in their classic "History of Nevada," 1881, write that John and Delia Brown arrived in Lahontan Valley in 1866. Brown was the owner of "a fine farm containing 660 acres of land, located on Old River, six miles below the old overland bridge and twelve miles from the county seat" with "160 acres under cultivation and a young orchard of promising fruit trees." Thompson and West further inform us that "Brown had begun to venture into stock-raising" and "may be considered very successful in the business." He also served as Justice of the Peace of Stillwater Township and Sheriff of Churchill County.

The first impression arising from the Thompson and West entry is that John Brown exemplified the portrait (even if somewhat romanticized) of the male pioneer: energetic, adventurous, and ambitious. In contrast, the entries in Delia Brown's diary suggest that what fed John's pioneer spirit starved her own.

John, while raising stock, cultivating a farm and orchard, and serving as Justice of the Peace and Sheriff, was constantly on the move and in the company of like-minded men. Delia, while raising a son and daughter on an isolated ranch and performing endless chores, was largely without any company except for her own and her children's.

July 26, 1868: My husband has gone from home today to look for some horses and it is very lonely when he is gone.

Oct. 31, 1881: John gone to Mr. Allen's.

Nov 1, 1881: John gone to Mr. Prichard's.

Nov. 2, 1881: John gone to Stillwater.

Nov. 4, 1881: John gone to Upper Sink again.

Oct. 29, 1882: Alone again today. Wonder if any other woman stays alone so much.

To add to the loneliness caused by John's frequent absences, she felt intense longing for the family she had left behind in Huntley, Michigan.

May 6, 1868: Eight years ago tonight was the last night I spent with loved ones in my far away home before starting on the trip "across the plains." My heart is sad tonight when I think of the changes since then. Oh how many loved ones are buried from sight and their places vacant! My mother, sister, niece and others and here I am far away from all. My heart grieves for the presence of them tonight. I would not murmur at the dealing of God for He doeth all things well and yet my heart is very sad.

Thirteen years later, her heart is still very sad:

May 7, 1881: Twenty-one years today since we bade a fond farewell to dear ones and started on our trip "across the plains." I will not dwell on the event. Suffice it to say that I so long for the sight of the faces of the few absent ones left.

Next week, I'll bring you more of Delia Brown's diary.




