First Responders Food Drive Yields Over 11 Tons of Food for Local Families

When it comes to Fallon's First Responder Food Drive, there is nothing like a little healthy competition between agencies to rev up the giving. This year's event yielded an outstanding result of 23,666 pounds of food, which will be distributed to area residents in need this holiday season. The program's cumulative impact, reaching a total of 146,454 pounds of donated food since its inception in 2016, not only highlights the generosity of Fallon's First Responders, but also underscores the exceptional sense of community that makes Fallon the caring and compassionate town that it is.

The department bringing in the most contributions was the Fallon Police Department at 6,506 pounds, with the Churchill County Sheriff's Office a close second at 5,060.

Steve and Raena Blais. Local favorites, wandering souls, musical magicians have returned home to Fallon for the holidays and will perform at the Fallon Theatre in concert on December 14, at 7 p.m.

Finding themselves empty nesters and displaced after 22 years from his contract job at the base, piled on top of the impermanence after the pandemic, Steve and Raena decided that time is a gift and they were going to invest in themselves and one wild adventure. They rented their house out, let go of many of their worldly possessions, and gutted and rebuilt their camp trailer into a beautiful home on wheels, setting out to wander the west.

“We wanted to leave by our 10-year wedding anniversary,” said Raena, and they were on the road in September of 2022, traveling over the past year through much of northern California, Oregon, Washington, Arizona, Utah, and Idaho.

They’ve stayed in the yards of friends, playing music at their BBQs, been off-grid, boondocking where they’ve played music in the desolate deserts of the west with friends they just met. They have “gigged” in every state they’ve explored and have made life-long friends of strangers, building a community network of nomads.

“These are the moments,” said Raena, “the reception we’ve gotten has been humbling.”

On of the places they played in Arizona loved them so much, after playing four shows, began introducing them by suggesting they “stop wandering, and stay here with us.”

This is what Steve calls the “job part of the career change,” building a social media following through their channel. “The more follows and likes, the online persona,” all goes to building a following and then hopefully partnerships, and sponsorships.

Outside of the beautiful photography and video that goes along with their music online, it’s the moments of music and the connections they build with their in-person audiences that have kept Steve and Raena enjoying their high adventure.

They have been able to visit family and each other’s friends, and they both say living in the trailer together has been great. “Wherever we go it’s home, and we’re together,” said Raena. And when they stay with friends, because they have their own house, they aren’t really guests, they’re neighbors.

Steve said sometimes it’s work to find where they’re going to stay, but the low-impact living has been enjoyable. He said Raena is often “moming” other nomads, and the friends they’ve made who are on adventures of their own have helped confirm what is really important in life.

“We’re living the dream – the life many people want,” he said.

But they are really excited to be back in Fallon after their travels, for the holidays, and before they set out again will play for their hometown friends. “The theatre is a great venue,” said Steve. “We’ve done our sound check and we will have great visuals. Annabelle is opening. It will be an evening people will remember.”

Their music self-describes as “from Led Zeppelin to the Beastie Boys” but also include simple, heartfelt original ballads. Tickets are \$12 per ticket.

Rebuild it and They Will Come - NAS Fallon Celebrates Bravo Runway Completion

In a momentous occasion, NAS Fallon marked the official reopening of the Bravo Taxiway. After a three and a half-year reconstruction effort, the project is officially complete.

On November 28, NASF officials held a ribbon-cutting ceremony to celebrate the successful completion of the project, which has transformed the airfield's critical taxiway. The revitalized Bravo Taxiway involved a large-scale upgrade, incorporating 19,000 cubic yards of new concrete, improved lighting systems, and freshly painted runway markings. This extensive overhaul demonstrates the Navy's commitment to maintaining cutting-edge infrastructure supporting vital air operations at NAS Fallon.

The structural integrity of the old runway was beginning to fail, and rebuilding became imperative. According to Gavin Graham, NASF Public Relations Officer, the project contract was awarded to Pave-Tech in March 2020, and work was underway by June. The total taxiway rebuild cost was around \$18.6 million.

"The taxiway shoulders were thickened, increasing them from six inches to a foot," said Graham. NASF Public Works Director, Lt. Dan Muller further explained that this was the first major renovation since Bravo's construction in 1953. The improvements expanded the runway, making it both deeper and wider.

Additionally, construction crews worked through numerous challenges

during the three-and-a-half-year-long project, not the least of which was Northern Nevada winters and difficult weather. While most of the work was handled by Pave-Tech, the local Naval Facilities Command and the Southwest Command (NAVFAC) played an essential role in the rebuild.

This endeavor's success is credited to various entities' collaborative efforts. During the ribbon-cutting, NAS Fallon extended its appreciation to Pave-Tech Inc. for their exceptional work in bringing the project to fruition. Gratitude was also extended to NAVFAC Southwest and the NAS Fallon Public Works Department for their invaluable support throughout the reconstruction process.



As NAS Fallon celebrates the completion of the Bravo Taxiway project, the enhanced facilities not only elevate operational capabilities but also contribute to the overall readiness of the base. This achievement reflects

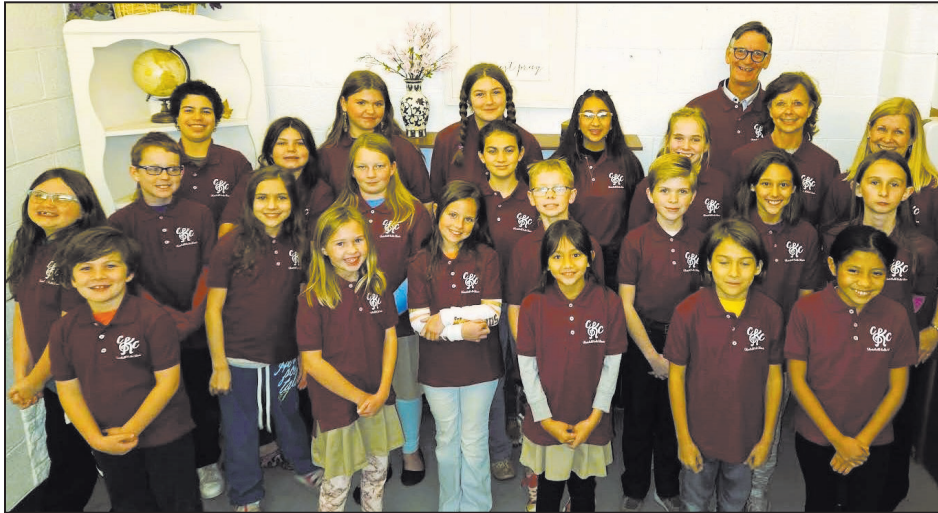

Senior Spotlight: Mackenzie Bryant

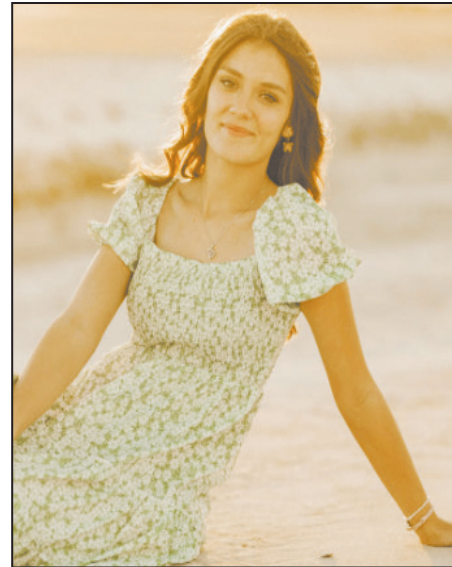
A snowy day in fifth grade will stick out as a favorite memory for graduating senior Mackenzie Bryant.

Law & Order

District Court News

The Tenth Judicial District Court convened Tuesday, November 28, Judge Thomas Stockard presiding.

Stacy Lynn Arias, in custody, pleaded guilty to the Category E Felony of Possession of a Controlled Substance, a first or second offense, punishable by 1-4 years in prison and a fine of up to \$5,000. DDA Thomas said this is a mandatory probation case. PD Sommer asked that, as a condition of probation, Arias be ordered to Western Regional Drug Court. The judge granted Arias probation and ordered her to obtain a substance abuse evaluation and follow all recommendations therein. She was placed in Drug Court and was to remain in custody until her first appearance on November 29.

John William Fullen, in custody, pleaded guilty to two Category C Felonies: 1) Offer, Attempt, or Commission of an Unauthorized Act Relating to The Manufacture or Compounding of Certain Controlled Substances, charged as a first offense; and 2) Fraudulent Act Concerning Gaming a first offense. Each of the felonies carries a potential penalty of 1-5 years in prison and a fine of up to \$10,000. Fullen was released on his own recognizance under Court Services supervision at the request of his court-appointed attorney, John Dadlic, Esq. A Pre-Sentence Investigation was ordered, and sentencing was set for February 20.

Kevin Franklin Russo, in custody, pleaded guilty to the Category D Felony of Embezzlement of a value of \$1,200 or more but less than \$5,000,

punishable by 1-4 years in prison and a fine of up to \$5,000. Stockard provisionally placed Russo into the Western Regional Drug Court program and left it to the discretion of Drug Court as to when he can be released. Russo will be supervised by Court Services with daily check-ins and random drug tests. A new Pre-Sentence Investigative Report was ordered. Sentencing was set for February 20, 2024.

Amanda Kaye Brown, in custody, pleaded guilty to four felony charges: 1) Obtaining or Possessing a Credit Card or a Debit Card or Identifying Description of a Credit Card, Credit Account, or Debit Card without Consent, a Category D Felony, 2) Possession of a Controlled Substance, a first or second offense, a Category E felony; 3) Offering False Evidence, a Category D Felony; 4) Conspiracy to Commit a Felony Crime Under the Uniform Controlled Substance Act charged as a first offense, which is a Category C Felony. Defense counsel for Brown, PD Noel, asked Judge Stockard to release his client on her own recognizance and to be provisionally placed in Drug Court. DDA Sanford opposed an OR release. The judge denied OR. However, if Brown can secure a date at an inpatient treatment facility, Stockard said he would consider a release to an inpatient program.

Selma Christina Sampley, in custody, appeared for sentencing upon pleading guilty to the Category E Felony of Possession of a Controlled Substance, a first or second offense (methamphetamine). Sampley received 18 months of probation on a suspended sentence of

14-40 months in prison. She was also ordered to obtain a substance abuse evaluation within the next 30 days and to follow the recommendations therein. Failing to do so will result in a probation violation. Fees and Assessments were imposed.

Sonnie Angelo Anzaldua pleaded not guilty to the Category C Felony of Battery Causing Substantial Bodily Harm, punishable by 1-5 years in prison and a fine of up to \$10,000. A Status Hearing was set for January 9, 2024, with a jury trial set for May 20-24, 2024.

Hubert Craig Allen pleaded guilty to the Category E Felony of Possession of a Controlled Substance, a first or second offense (methamphetamine). Allen received 18 months of a suspended sentence of 12-32 months in prison. Allen was also ordered to obtain a substance abuse evaluation and to follow the outlined recommendations. Fees and Assessments were imposed.

Daisy Fran Dennison pleaded guilty to the Gross Misdemeanor of Conspiracy of an Ex-felon in Possession of a Firearm. Dennison was fined \$300.

Wilford E. Crutcher appeared for sentencing for Driving Under the Influence of an Intoxicating Liquor or Controlled or Prohibited Substance, a second offense. The judge noted that Crutcher graduated from the Western Regional DUI Diversion Course and fined Crutcher \$750, which is the minimum fine allowed by statute. An interlock device must be installed on any vehicle registered to or operated by Crutcher for 18 months.

Joshua Jamar Harvey appeared for sentencing on the Category E Felony

of Possession of more than 1 ounce but less than 50 pounds of Marijuana, or more than 1/8 ounce but less than 1 pound of Concentrated Cannabis, which he pled guilty to in October. Judge Stockard found Harvey eligible for Drug Court and placed him on probation for one year with the condition that Harvey enter and complete the Western Regional Drug Court.

Larry Lee Puchert, in custody, pleaded guilty to the Category E Felony of Possession of a Controlled Substance, a first or second offense. A Pre-Sentence Investigation was ordered, and sentencing was set for February 20, 2024. Puchert was provisionally placed in Drug Court, who will determine if he is to be released. If released, he will be under the supervision of Court Services.

Continuances:

- Randy Lee Hutchcraft's arraignment was continued to January 9, 2024.
- Christopher Colby Ingram's sentencing violation hearing was continued to April of 2024. The date for an evidentiary hearing will be set administratively.
- Selina Muncy's sentencing was continued to January 2, 2024.
- Matt Charles Lane's sentencing violation hearing was continued to January 9, 2024.

What's Cooking in Kelli's Kitchen - Bacon Brussels Sprouts

The time between Thanksgiving and New Year's ranks near the top of my Favorite Times of Year list. We fill the season of long nights and cold temperatures with opportunities to celebrate together.

Whether it be our hometown Fallon Christmas Tree Lighting or Thanksgiving Dinner at home with just my spouse, I enjoy sharing time in reflection and communion. This is the season of gratitude, so I want to take a moment to uplift and celebrate a man who often stands in my shadow, who is unwavering in his support and encouragement of me, and who is the reason that I can do what I do every single day, Neil Kelly. I am so grateful to have found a partner in Neil—he is funny and kind, in touch with his emotions, and fiercely protective. He willingly makes sacrifices to benefit our little family and our larger community. He does it all for the joy of doing it—never needing or wanting to be centered in the spotlight. He asks for very little in return—just regular “shoulder rubbies” and an occasional beef stroganoff or tuna casserole. I hate tuna casserole.

When we first met, Neil told me that the only food he did not like was Brussels sprouts. I took it as a challenge and immediately decided to make a Brussels sprouts dish that Neil tolerated and enjoyed. One night at dinner, while on our honeymoon in the Napa Valley, I ordered a side of Brussels sprouts. They were roasted in the oven until crispy and golden brown, served with bacon and parmesan cheese with a drizzle of balsamic

glaze—they were delicious. After a few exaggerated facial expressions and audible sounds of pleasure, Neil relented and tried a bite. The challenge was over. The only Brussels sprouts he had tried started frozen and were boiled to death in the style endemic of 1980s middle America—smooshy, gassy, and generally unpleasant.

This weekend, I made Brussels sprouts. They are in season right now and are available on the stalk the way they grow in the field. As I prepared them, I thought about my husband—how grateful I am that he trusts me enough to try anything I put before him, even the one food item he told me he found repulsive. I also thought about food aversions in general. Maybe I only think that I wouldn't say I like hot tuna because I haven't had it in a way that I like it yet.

So, I challenge you to try these Brussels sprouts and send me your best tuna casserole recipes.

Serious Eats' Roasted Brussels Sprouts with Bacon by Jennifer Segal

INGREDIENTS:

½ cup pecans
6 slices bacon
2 lb Brussels sprouts, halved (stems and ragged outer leaves removed)
3 T extra virgin olive oil
1 t kosher salt; for table salt, use about half as much by volume or the same weight
½ t black pepper
2 ½ T balsamic vinegar
1 T maple syrup

DIRECTIONS:

1. Adjust oven rack to center position and preheat oven to 350°F. Line a baking sheet with heavy-duty aluminum foil.
2. Place pecans on the prepared baking sheet and bake until lightly toasted and fragrant, about 5 minutes. Keep a close eye on them, as they can burn fast. Transfer nuts to cutting board and chop coarsely. Set aside.
3. Increase oven temperature to 400°F. Lay the bacon strips flat on the same foil-lined baking sheet, leaving space between them so they don't overlap. Roast until bacon is crisp, 12 to 20 minutes, rotating halfway through. Cooking time will depend on the thickness of bacon. Transfer bacon to a plate lined with paper towels; pour rendered bacon fat into a small dish discard aluminum foil. When bacon is cool, finely chop.
4. Increase oven temperature to 425°F. Line baking sheet with fresh aluminum foil. Toss Brussels sprouts with rendered bacon fat, olive oil, salt, and pepper directly on baking sheet. Roast, stirring midway through to promote even browning, until Brussels sprouts are tender and caramelized, about 20 minutes. Add balsamic vinegar and maple syrup, toss to coat evenly. Taste and adjust season-

ing, transfer to serving dish. Right before serving, top with chopped pecans and bacon. Serve hot or at room temperature.

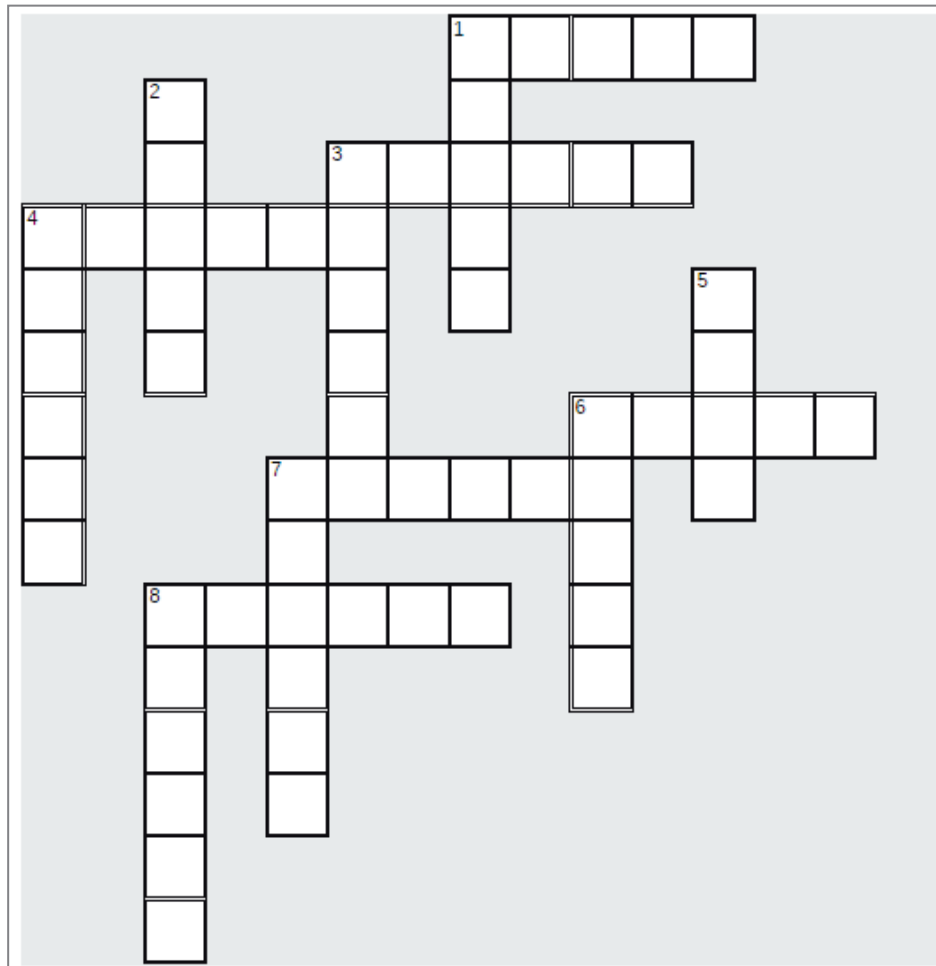

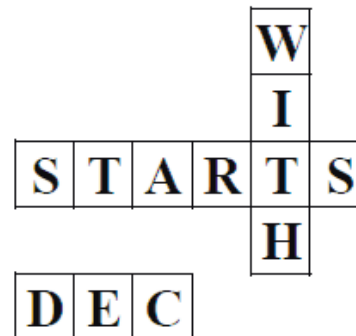


